**Comments from Ward Cllr.:-**

**From the quarterly report:-**

- 1) Could I impress upon everyone to get involved. In order to be able to act, WNC needs to know the issues. **Previous Minutes:-** It was proposed and seconded that the minutes of the meeting held on Tuesday 4<sup>th</sup> November 2025 be approved and signed.

**Matters Arising:-** 1) New email addresses for clerk and chairman in progress. This will be done when a direct debit is set up to pay for the website at the next due date.

**EV Charging point at Village Hall:-**

The Parish Council discussed this at length but cllrs. felt they could not support the installation of a charging point at the village hall for the following reasons:-

- 1) No information was given on the number of potential users
- 2) No information was given on whether there would be sufficient charging capacity for the number of users
- 3) No information was given regarding the administration of the points i.e. an adequate booking system and method of cash collection.
- 4) No information was given regarding the arrangement of parking when waiting for a charging point.
- 5) No information regarding the number of car parking spaces being lost to accommodate queuing for the points and using the points.
- 6) It is surely inevitable that some car parking spaces will be lost which will lead to more parking on the already congested roads.

**Speed Restrict on Kelmarsh Road:-**

A complaint was received at the last meeting regarding speeding vehicles on Kelmarsh Road in the village. A request was made to extend the speed restriction zone but requests have been made previously to WNC. The requests have been presented to a panel including Police, Highways etc. and there has to be considerable evidence before a case is presented. A speed restriction in the village would not be considered as it also would not be enforceable. The meeting agreed to investigate hand held speed cameras (Community Speed Watch) which will involve village volunteers to take part or purchasing a fixed speed camera (Vehicle Activated Sign) which will require fund raising. To be discussed further at the next meeting when details are available.

**Enlargement of existing pond**

Planning permission has been granted with the following conditions:-

- 1) Development begun within 3 years
- 2) Development strictly in accordance with the submitted plans
- 3) If, during development, contamination not previously identified is found to be present at the site then no further development (unless otherwise agreed in writing with the Local Planning Authority) shall be carried out until a remediation strategy detailing how this contamination will be dealt with has been submitted to, and approved in writing by, the Local Planning Authority. The remediation strategy shall be implemented as approved.
- 4) Prior to commencement of works, a landscape scheme shall be submitted. If within a period of five years from the date of the planting of any tree or shrub, they, or any planted in replacement for them, are removed, uprooted or destroyed or die (or becomes in the opinion of the Local Planning Authority, seriously damaged or defective) another tree or shrub of the same species and size as that originally planted shall be planted at the same place, unless the Local Planning Authority gives its written consent to any variation.
